Toward JPFP's 50th Anniversary #6

Support for the establishment of regional fora and national committees on population and development

Today, many countries have a parliamentary caucus working on population and development issues, forming a global network. This is an initiative by the Japan Parliamentarians Federation for Population (JPFP) that has been in place for many years to encourage the founding of such parliamentary groups in respective countries. JPFP's founding principles explicitly state that "5. We trust that JPFP will inspire other countries around the world to form their own supra-party groups on the issues of population and family planning and would like to take this opportunity to strongly urge them to do so".

In September 1977, three years after the foundation of JPFP, a parliamentary delegation led by Hon. Kishi Nobusuke (Chair of JPFP) went on a tour to Mexico, Colombia, Brazil, the U.S. and Canada and called upon fellow parliamentarians of each country to form a group that would address population and development issues[1]. In December 1977, Hon. Sato Takashi and other JPFP members visited the U.K. and West Germany and encourage them to do the same, and their efforts continued in the following years. Hon. Sato (Chair of AFPPD) mentioned that the number of parliamentary groups on population and development in the world exceeded 40 in 1984[2].

Under JPFP's active leading role, the Asian Forum of Parliamentarians on Population and Development (AFPPD) was formed in 1982, followed by the formation of the Inter-American Parliamentarians Group on Population and Development (IAPG) in 1983, which promoted the institutionalization of the network. The 1994 International Conference of Parliamentarians on Population and Development (ICPPD) in Cairo led to the establishment of the Forum of African and Arab Parliamentarians on Population

and Development (FAAPPD[3]) in 1997, which encompassed the Africa and Arab regions. Then, the 1999 International Forum of Parliamentarians for the Five-Year Evaluation of ICPD (IFP), which was also led by JPFP, provided the impetus for the establishment of the Inter-European Parliamentarians Forum on Population and Development (IEPFPD[4]) in 2000. With that, the network covered all regions of the world.

Through this network, JPFP and its secretariat APDA continue to make sustained efforts at home and abroad by providing parliamentarians with platforms to raise awareness, share experiences, and build partnerships to address population and development issues, as well as to urge the Japanese government and other donors to support these activities. These efforts are resonating across time and countries: at the Africa-Asia Parliamentarians' Dialogue co-hosted by APDA, FPA, and the Parliament of Rwanda in Kigali, Rwanda, in October 2023, a proposal was made and agreed to encourage countries in Africa that do not yet have a parliamentary group on population and issues to create one.
